Sub.: - Commencement of Haj - 1443 (H) - 2022 (C.E.).

With reference to our Circular No.12 dated 09.04.2022 and as per email received from Consul General of India, Jeddah the Quota of pilgrims proceeding for Haj 1443 (H) – 2022 (C.E.) through Haj Committee of India has earmarked as 56,601. In this context the following checklist / preparation to be made by the State / UT's Haj Committees at respective Embarkation Point for Haj -2022. The chart of tentative Quota is enclosed as (Annexure-I).

- 1) Due to paucity of time left after the haj announcement is made, State / UT Haj Committees may inform all the intending pilgrims of their State that they should get them ready in all respects for proceeding for Haj and also keep their passport and Haj amount readily available, which will be required to be deposited as soon as Qurrah (Draw of lot) will be conducted / Amount to be paid by the pilgrim will be notified separately.
- 2) All concerned State / UT Haj Committees of enlisted embarkation point for Haj-2022 may make all related arrangements at their embarkation point following their State / Health Department Guidelines issued for the precaution of Covid-19. The following arrangements may be made available for the facilitation of the pilgrims proceeding for the Kingdom of Saudi Arabia.
 - a) Suitable arrangement of accommodation is to be made available for the pilgrims within the premises of Haj Camp is to be organized.
 - b) Sufficient number of use of lavatories / washrooms, wherever necessary may be made available thereby maintaining proper hygiene in the premises.
 - c) Proper supply of drinking water and arrangement of hygienic food may be made available to the pilgrims during their stay at embarkation point.
 - d) State /UT Haj Committees may arrange suitable space for Medical/RT PCR test to be done of the intending pilgrims before 72 hours of boarding of their flight at the embarkation point, as it is mandatory as per the guidelines issued by the Kingdom of Saudi Arabia.
 - e) Vaccination camps may be organized in the haj camp to be inoculated to the intending pilgrims.

f) State / UT Haj Committees may arrange space available for the distribution of bedsheets / pillow covers / umbrella for each pilgrim travelling for haj -2022.

g) Proper Sanitization of the premises / accommodation of the pilgrims and office area, maintaining social distance and all Covid-19 guidelines of

the State may be strictly followed.

- h) State Haj Committee may be made available suitable office space for Banks and Airlines for issue of Foreign Exchange currencies / Boarding passes to the pilgrims.
- 3. All State / U.T. Haj Committees are therefore requested to make necessary preparation / arrangements accordingly, to avoid last moment hassles. The Haj Committee of India alongwith all SHCs are looking forward for successful completion of Haj -2022
